Dear Destinations Career Academy of Georgia Families,

Subject: Annual Notification of Family Educational Rights and Privacy Act (FERPA)

Destinations Career Academy of Georgia (GADCA) is committed to ensuring that our families are fully informed about their rights under the Family Educational Rights and Privacy Act (FERPA- 34 CFR § 99.7). This federal law protects the privacy of student education records and provides you with specific rights regarding your child’s educational information.

Your Rights Under FERPA Include:

**The Right to Inspect and Review Records:** You have the right to review and inspect your child’s educational records maintained by the school. To request access, please contact the school’s main office at [schooloffice@gadca.org](mailto:schooloffice@gadca.org).

**The Right to Request Amendments:** If you believe your child’s educational records are inaccurate, misleading, or otherwise in violation of privacy rights, you have the right to request an amendment to the records. Please submit an email request detailing the changes to the school’s main office at [schooloffice@gadca.org](mailto:schooloffice@gadca.org) with the Subject Header: FERPA - CRF99.7 - Request for Amendments.

**The Right to Consent to Disclosures:** Generally, GADCA must obtain your written consent before disclosing personally identifiable information from your child’s education records. However, there are certain exceptions under FERPA, such as disclosures to school officials with legitimate educational interests or in response to a judicial order.


**The Right to File a Complaint:** If you believe that GADCA is not compliant with FERPA, you have the right to file a complaint with the U.S. Department of Education at 1-800-USA-LEARN (1-800-872-5327).
